
Quotation agreement

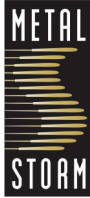
