
Quotation agreement

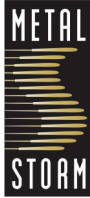
