
Quotation agreement

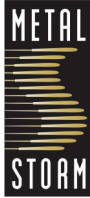
